DeSub Committee

- This committee is one of the largest committees EACO has had with 18 consultants, 2 labs, 4 contractors and other representatives from the Industry.
- There has been 3 meetings to date and a draft outline of the document is being prepared.
- This will be an industry guideline for performing pre-construction designated substances and hazardous materials assessments on construction and demolition projects. It will be designed as the "standard" for performing assessments and will provide information on all related requirements for performing these assessments across a wide range of projects.
- This committee and subsequent document was initiated through EACO's partnership with the ISHA and its work on the demolition sector committee.
- The document should be ready in late fall 2017.

- There was discussion about a "Recognized EACO Contractor" category similar to the EIA.
- There was discussion about an insurance program for members.
